The Board of Directors and staff thank you for your continued support through this very challenging year. The year 2020 will be remembered in many ways; not the least of which is the Covid-19 pandemic crisis.

But let's not give Satan any credit here. God has protected the guests and staff of the Christian Shelter like no other year in the past. We are thankful for good health and for the good protection over our space. You, the community, continued your support – even growing it – as we navigated the year. We have seen and felt individuals, churches, foundations and businesses step out in faith, even though the economy was devastated with closures and slowdowns. God allowed us to develop a computer lab in which all the laptops were donated as were the table and chairs. We test our guests and staff every month for COVID-19 through a partnership with the Wicomico County Health Department. To date, we haven't had a single “positive” test. We developed a new partnership with Amerigroup Maryland, Inc., who has graciously sponsored a number of special events for our guests especially around the holidays. They have agreed to continue those sponsorships into the 2021 year again to help our guests find a reason to celebrate even while having to seek assistance here at the Christian Shelter. A number of significant new donors emerged as well, and we are blessed to have them.

We have clear goals for 2021. Our pressing need is to replace the roof on the building. We want to renovate the dining room, the day room and the front office. We are hopeful that the City of Salisbury will transfer to us the deed for a parcel of land behind the shelter. The land will provide the area needed to build a playground for our children.

We thank every one of you who donated to the Christian Shelter in many ways. Your contributions will allow us to eventually transition our guests into a home of their own one day. It is our endeavor to move our guests from dependency to self-sufficiency. On behalf of the Chairman of the Board, myself and the entire Board, we thank you as we “Strive Towards Excellence Through Righteousness in Christ Jesus”.

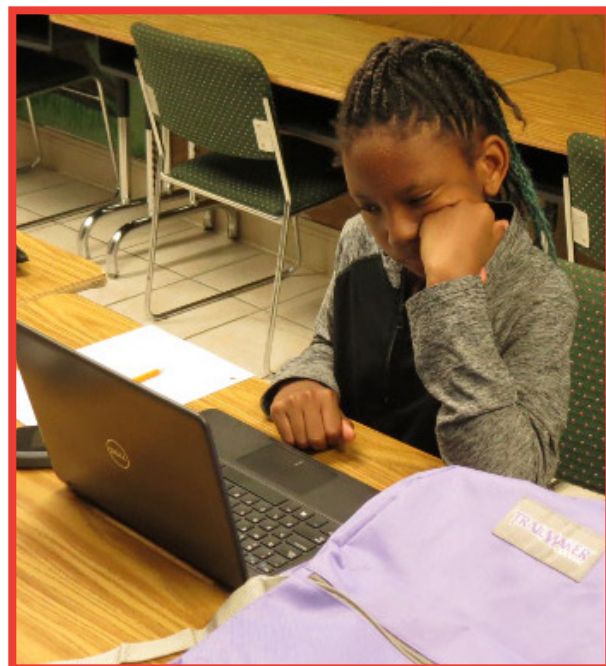

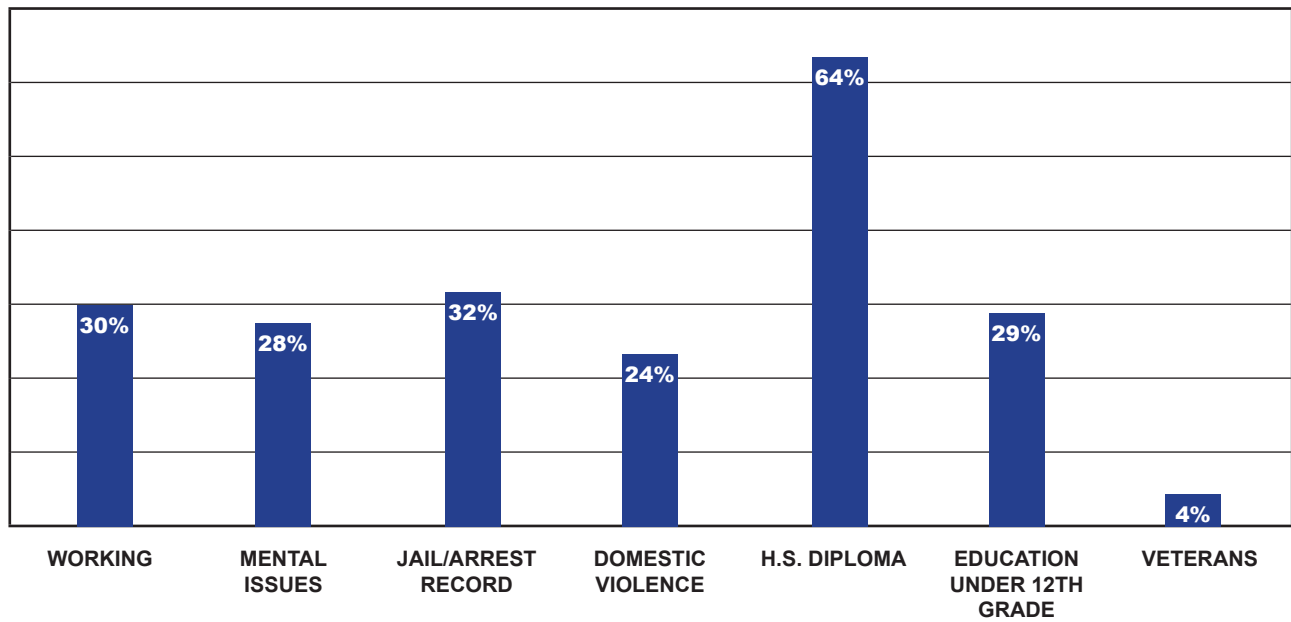

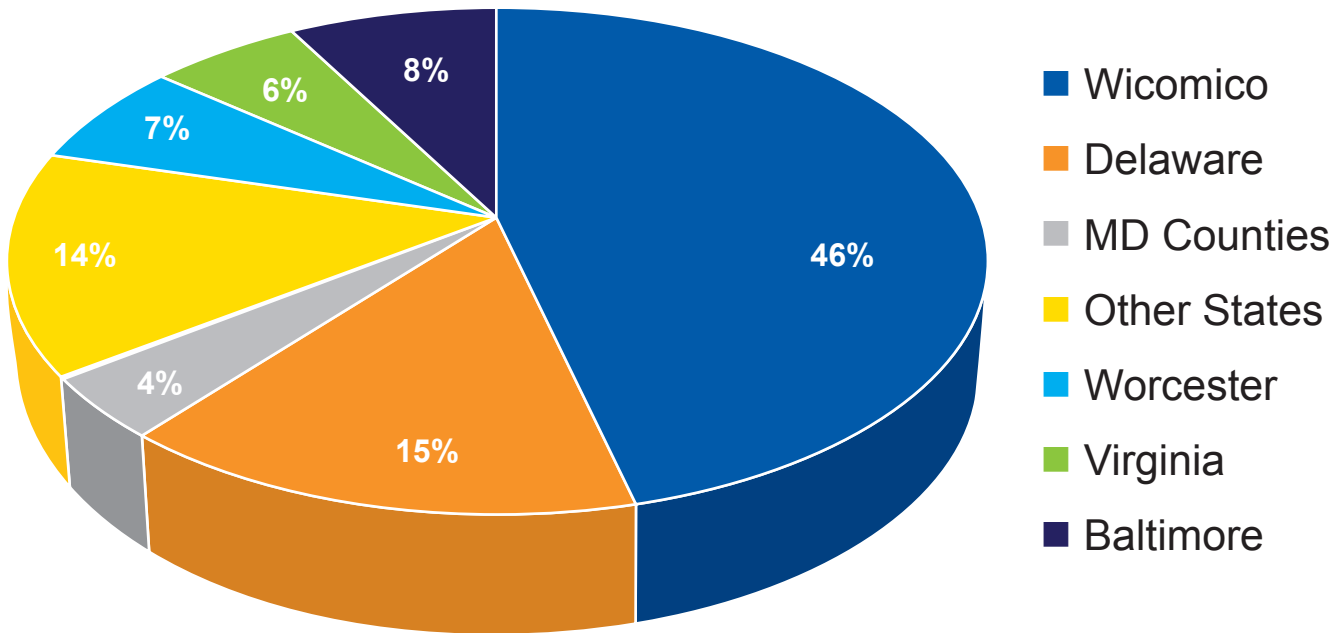

2020 TOTAL EXPENSES

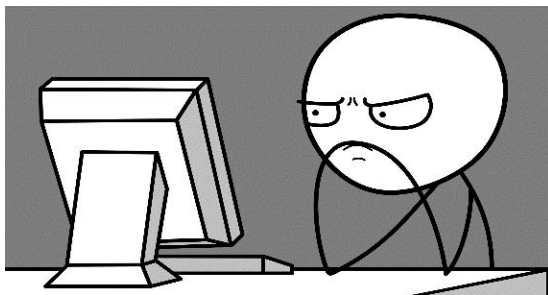
